## ELIGIBILITY

- Full-time FSA members are eligible to be a candidate for the President, Vice President, and Director-at-Large positions.
- Associate FSA Members (this includes all current Part-time Studies Instructors and Lab Assistants) are not eligible for to be a candidate for the President, Vice President or Directors-at-Large positions.
- Ancillary FSA Members (Markers, Student Employees and Guest Lecturers) are not eligible to be a candidate for the President, Vice President, or Directors-at-Large positions.
- All Members may *nominate* and *vote* for these positions.

## TERM OF SERVICE

- The two (2) Directors-at-Large will serve the remainder of the two (2) year term from June 1, 2019 until May 31, 2021.
- The President and Vice President will serve the two (2) year term from June 1, 2020 until May 31, 2022.
