ELIGIBILITY

- Full-time Regular FSA members in good standing are eligible to be candidates for one (1) Treasurer and one of five (5) Director-at-Large positions.
- Associate FSA members (this includes all current Part-time Studies Instructors and Lab Assistants) are eligible to run for one of two (2) Director, Associate Members positions.
- Ancillary FSA members (Markers, Student Employees and Guest Lecturers) are ineligible to hold Board positions, however all FSA members may *nominate* and *vote* for these positions.
